



Dear Families,

The HealthHUB Dental Hygiene trailer will be available to provide dental hygiene services for children at your school again this year. HealthHUB's mission is to deliver high quality, prompt, cost-effective medical, dental and mental health services to children, infancy through high school. It improves access to care so your children can easily maintain their preventative health care needs. The dental hygiene services provided will include 2 preventative dental cleanings, an oral evaluation, necessary x-rays, fluoride treatments and sealants (when necessary and upon parent permission).

All students are eligible provided they have NOT had their teeth cleaned elsewhere within the last 6 months and who are enrolled into the program.

The HealthHUB dental program accepts private dental insurance, Medicaid and cash payment. It is necessary to provide **ALL** of your insurance information on the opposite page to be able to provide care. **If your child has had their teeth cleaned within the last 6 months, they will not be eligible for insurance coverage.** If you need information on getting your child enrolled for VT Medicaid coverage, please feel free to ask. The fee schedule is posted on the HealthHUB website at healthhubvt.org, under the dental tab on the left. **Please complete the reverse side of this paper ENTIRELY and return it to the school secretary or school nurse.**

2017-2018 Dental Enrollment Form

By signing this form and enrolling my child(ren) in the HealthHUB dental program, I understand:

- Treatment performed by the dental hygienist is limited in scope, according to the Vermont Statutes and Rules of dental hygiene scope of practice, and that it does not take the place of a regular dental examination or treatment by a licensed dentist.
- The dental hygienist works collaboratively with school nurses, dentist offices and other HealthHUB providers with whom communication and records may be shared and will be kept confidential.
- Dental records for services provided by the dental hygienist will be reviewed by a VT -licensed dentist in which the dental hygienist holds a general supervising agreement.
- It is my responsibility to follow up with any treatment or examination, by a DENTIST, that the dental hygienist recommends for my child.
- It is my responsibility to pay HealthHUB for services rendered, if my child does not have Medicaid or private dental insurance. I also understand that I will pay any co-pays with private insurance.
